- f. It aims at improving educational status of weaker, vulnerable needy and marginalized groups of the society. It emphasizes on the girl's education and aims at establishing educational institutions in remote areas.
- g. It aims at providing for grants, scholarships, fellowships and other forms of financial assistance to the students belonging to needy weaker and marginalized groups of the society for pursuing education.
- h. It aims at generating health awareness and provides health facilities, including family planning programmes establishment, conduct, establishment and maintenance of clinical laboratories, hospitals, nursing homes, dispensaries and institutions of similar nature and providing financial assistance to the needy people for medical treatment, in any medical institution.

- q. Apart from aforesaid, trust collaborates with other agencies, institutions and organizations in terms of intensive research and developmental activities on the above mentioned issues. Initiate action projects for the well-being of mankind and establish an equitable society with respect to all religions and to carry out activities for creation of social harmony in the society.
- r. The objectives of this trust are purely based on welfare of the society and not commercial.
- s. The Trust shall not carry out any activities with the intention of earning profit and will perform with service motive only. Money generated from the trust will be spending only on the aforementioned welfare activities of the society.

1. The Trust shall not carry out any activities confining its objects for the benefit of a particular religious community
2. All activities of the trust will be conducted in India
3. Notwithstanding the above the trust may conceive of and implement any other project designed to advance and for the furtherance of the objects of the trust as set out above.

4. BENEFICIARIES OF THE TRUST:


The benefit provided by the trust are available to the general public and it is not restricted to any particular religion, community, caste, creed, sex, etc. the activities.

5. BOARD OF TRUSTEES:

- a. All the trustees who are for the time being, and from time to time, in office shall be referred to collectively as the "BOARD OF TRUSTEES"
- b. The number of Trustees shall be neither less than 2 (two) nor more than 21 (Twenty One). The trustees shall hold the following positions in the Board:
 - i. Shri. Ravindra Kumar Yadav (Founder/Managing Trustee)
 - ii. Smt. Sanju Yadav (Founder/Managing Trustee)
- c. The managing Trustee of the Trust Board shall have all the powers of the management of the trust and its properties in consultation with other members of the Board of the Trustees and shall have the power to delegate any of his power to any of the trustee as she/he may deem fit. The joint managing trustees will be empowered to execute the power in the absence of the managing trustee in consultation with other members of the board of the trustee.
- d. The Board shall be entitled to appoint Trustees in addition or to fill up any vacancy in the board arising but subjects to the limits fixed in clause 5(b) supra, the Board can meet for the purpose of filling up the vacancy and the board shall be competent to transact business only when the minimum is brought to the number fixed in clause 5(b) supra.
- e. If any of the trustees in any way incapacitated, unwilling to or is unable to hold the Office as trustee or dies, the Board may appoint new trustee/s in place of such trustee/s.
- f. The board shall be competent to transact business of the trust notwithstanding the fact that some posts of trustees are vacant.
- g. The founder/managing trustee, shall remain Lifetime trustees or until they choose to resign from the post, all other trustees shall hold the office for a period of three years and shall be eligible for reappointment if so desired, for the further period of not exceeding three years at a time.
- h. The trust will have a advisory board consisting of not less than two members.

- i. In the event of any vacancy in the office of the managing Trustee/Chairman/Vice Chairman by resignation or otherwise of any one of them. The designated Trustee will be chosen by

- i. 6. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

MANAGEMENT:

With a view to augment the trust funds and for proper administration of the trust the Board of Trustees shall have the following powers.

- c. - e. To raise loans, receive monies, securities or other movable property on behalf of the Trust.
- f. To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.

To compromise and compound all actions, suits, and other proceedings and settle differences and dispute touching the trust estate and /or the trust properties and to refer any such references or disputes to arbitration and to adjust and settle all accounts relating to the trust Estate and or the trust properties and to do all other acts and things fully or effectually without being liable or answerable for any bonafide loss occasioned thereby.
- o. To join co-operate or work with any trust, or institution in any joint programme or activity upon such terms as they may in their absolute discretion think fit as long as it is done in a manner not inconsistent with the objectives of the trust.
- p. To issue receipts for any moneys, stocks, funds, shares, securities or investments paid delivered or transferred to them in exercise of the trust or powers paying delivering or transferring the same.
- q. To frame schemes, and rules regulations for managing the affairs of the trust and for giving effect to the objects of the trust and may vary the schemes rules and regulations from time to time as they may in their discretion deem necessary and proper.
- r. To do all acts for the benefit of the trust and thus not be personally liable for any act bonafide of the trust in the course of duties as A TRUSTEE

8. INCOME AND FUNDS

- a. The funds of the trust (hereinafter called the "Trust Fund" which expression shall include cash and any other property or investment of any kind whatsoever in to which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise however in relation to these presents) shall be utilized towards the objectives of the trust.

11. ANNUAL ACCOUNTS AND BOOKS


